B. Business Usage

1. Business Local Usage Services:

Customers are provided a discount off of the month-to-month local usage rates listed below generally based on a term commitment of one, two or three years. The local usage penalty for early termination is the total local usage discount received by the customer calculated as the difference between the total local usage charges billed to customer at the discounted rates and the total local usage charges that would have been billed at the month-to-month rates listed below.
